Lesotho Revenue Authority (LRA) is piloting customs modernisation programme at Maputsoe, one of the busiest border posts between Lesotho and Republic of South Africa. The programme is intended to introduce and implement new procedures and processes for management of imports and exports, which will ultimately improve efficiency of the border management and reduction of costs for businesses. The changes are in line with the international standards of the World Customs Organisation, World Trade Organisation and standardisation within the Southern African Customs Union (SACU).

Q3: LONG DESCRIPTION OF THE CASE STORY

The programme has been initiated to address the problem of congestion through simplification of procedures, introduction of computerised declarations, documentation and advanced clearance.
